For a student to participate in Segment 2, verification must be received that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent or guardian (or parent designee) on a Level 1 License which has been held for not less than 3 continuous months.

TERMS

1. The parent or guardian agrees to pay the amount of \$50 at time of registration, either by check, cash or money order. **Registration is not complete without payment.**
2. Requirements to pass the course are as follows: Student must have no absences unless prearranged make up time with instructor has been made and a minimum of 70% on State Test (2 retakes allowed, if needed).
3. The cost for the class is \$50. Check, cash or money order is accepted. A returned check fee of \$15 will be charged and the student's certificate may be held until costs are covered.
4. In case of a student's absence or emergency, Oceana Driving School or student's instructor **MUST** be notified ASAP.
5. The makeup day policy is as arranged with your student's instructor.

REFUND POLICY

If for any reason you decide to withdraw from the course before its completion, a refund will be based on the following:

1. A full refund will be issued if you withdraw **before the first session.**
2. A partial refund will be issued based on the sessions attended.
